2. The candidate should not be a registered student of any University / Institute.
3. The appointment will be purely on contractual and temporary basis. He will be terminated after completion of project or due to non availability budget.
4. The selected candidate has to join under the control of Chief Agronomist, AICRP on IFS, VNMKV, Parbhani.
5. The candidate will have to appear for interview at their own cost.
6. The powers to accept or reject any application are reserved by the competent authority.
7. Original certificates will have to be produced at the time of interview.
